Waiver

I do hereby agree to let my child play with any team which he/she is assigned to by the San Juan Parks & Recreation Department and my child will properly care for the uniform and equipment provided for his/her use.

I, parent or guardian of _____ hereby give approval for participation in any and all San Juan Parks & Recreation activities. I hereby grant permission to managing personnel or other League representatives to authorize and obtain medical care from any licensed physician, hospital or medical clinic should the player become ill or injured while participating in league activities away from home, or when neither parent or legal guardian is available to grant authorization for emergency treatment. I assume all risks and hazard incidental to such participation, including transportation to and from the activities; and do hereby waive, release, absolve, indemnify and agree to hold harmless the Parks & Recreation and the City of San Juan employees, it's organizers, sponsors, supervisors, participants and persons transporting the player to and from activities - for any claim arising out of an injury to the player.

I further agree to furnish a birth certificate for the player upon request of League officials and return, upon request, the uniform and other equipment issued to the player in as good a condition as when received, except for normal wear and tear in League activities.

Accident insurance is provided for all registered participants of the San Juan Parks & Recreation Programs. The insurance serves as primary insurance for participants who do not have insurance and as secondary insurance of those that do. In case of injury, please ask your coach about necessary insurance forms.

Photos and video are periodically taken of participants in a class, during special events, or at various parks and recreation facilities. I understand that these photos are for the Parks and Recreation Department's use only and may be used in future brochures or publication. I do hereby grant permission for pictures or video to be taken of my child for purposes of publicity.

Parents' Code of Conduct

San Juan Parks & Recreation Department

Objective

The San Juan Parks & Recreation Department is designed to implant in the youth of the community the ideals of good sportsmanship, honesty, loyalty, courage, and scholarship, so that they may be finer, stronger and happier youth who will grow to be good, healthy adults.

I therefore agree:

1. I will not force my child to participate in sports.
2. I will remember that children participate to have fun and that the game is for youth, not adults.
3. I will inform the coach of any physical disability or ailment that may affect the safety of my child or the safety of others.
4. I will learn the rules of the game and the policies of the league.
5. I (and my guests) will be a positive role model for my child and encourage sportsmanship by showing respect and courtesy, and by demonstrating positive support for all players, coaches, officials and spectators at every game, practice or other sporting event.
6. I (and my guests) will not engage in any kind of unsportsmanlike conduct with any official, coach, player, or parent such as booing or taunting; refusing to shake hands; or using profane language or gestures.
7. I will not encourage any behaviors or practices that would endanger the health or well being of the athletes.
8. I will teach my child to play by the rules and to resolve conflicts without resorting to hostility or violence.
9. I will demand that my child treat other players, coaches, officials and spectators with respect regardless of race, creed, color, sex or ability.
10. I will teach my child that doing one's best is more important than winning, so that my child will never feel defeated by the outcome of the game or his/her performance.
11. I will praise my child for competing fairly and trying hard, and make my child feel like a winner every time.
12. I will never ridicule or yell at my child or other participant for making a mistake or losing a competition.
13. I will promote the emotional and physical well being of the athletes ahead of any personal desire I may have for my child to win.
14. I will respect officials and their authority during games and will never question, discuss, or confront coaches at the game field, and will take time to speak with coaches at an agreed upon time and place.
15. **I WILL REFRAIN FROM COACHING MY CHILD OR OTHER PLAYERS DURING GAMES AND PRACTICES, UNLESS I AM ONE OF THE OFFICIAL COACHES OF THE TEAM.**
16. **PARENTS ARE RESPONSIBLE FOR THE COST AND RETURN OF ALL EQUIPMENT ISSUED OUT BY THE SAN JUAN PARKS AND RECREATION DEPARTMENT. IF THE EQUIPMENT IS NOT RETURNED OR LOST, A BILL WILL BE ISSUED TO PARENT OF THE PARTICIPANT.**

The Parents' Code of Conduct must be signed before your child is registered. If it is not signed your child will not be able to participate in any activities with The San Juan Parks & Recreation Department.
